From the Chair.

Welcome to a belated Packet, It has been a busy winter and spring season.

Planning Developments.

We delayed publishing in the hope that we'd have news of a successful planning application by now, but unfortunately we seem to be inching very, very slowly over the line. The latest date we have is 21st June for the Derby City Council Planning Committee to hear the application, but this time the Trust have sought assurances from key officers that the date is the real one. Since I last wrote we have dealt with:-

- Wildlife objections from Derbyshire Wildlife Trust and Natural England.
- Highways and Environment Agency questions.
- Objections from pension trustees holding the Acordis/Celanese land.

The wildlife objections required us to complete surveys on habitat and impact on water voles, bats, greater crested newts and badgers. Fortunately the Trust managed to negotiate the headline fee from Middlemarch Consultants of £55,000 down to £8,000. Thanks to them for their sympathetic and prompt approach. I am sure they will be able to undertake further work at better rates as the project progresses. As a result of these studies the objections have been lifted.

It seemed a little unfair that we should be subjected to this late objection, but opinions sought suggested that if we hadn't done so we would have been in danger of any permission being contested later. We believe that Derbyshire Wildlife Trust and Natural England who raised the objection were broadly backing the application but were obliged to object. I'm sure they recognise that a large part of the restoration will look to protect and encourage natural habitat and wildlife.

As a result of this expenditure the Trust is looking at all ways possible to raise funds for this unexpected bill. Not to have pursued this action would have risked the planning application and potentially the whole restoration project. The challenge now rests to find the money to clear the expenditure. Any help on fundraising would be most appreciated and as ever if you can think of anyone interested in joining please let us know.

<u>Interpretation Panels</u> have now been installed at six locations along the route. The aim has been to fill in gaps between existing boards. Early reports show they are attracting a lot of attention, particularly at Swarkestone where boaters

and walkers are detouring up the canal path to read it. You'll see the new look boards at:-

- Swarkestone Lock 50 yards up the canal path
- Just south of the Harvey Road crossing,
- Pride Park by the culvert and the turn to the new Barrett estate,
- Draycott outside the Co-op cottages on Hopwell Road,
- Outside the Navigation Inn at Breaston
- By Cockayne's Bridge in Sandiacre.

There are already boards at Shelton Lock, Spondon (two by courtesy of the Spondon Community Association) and by the Sandiacre junction with the Erewash Canal. This means that no-one using the path can be in any doubt of the history of the canal and our intentions to restore it. Once we have the publicity from a successful planning application they will help us to promote the next stages and encourage further memberships. I'm sure there will be a challenge to keep the boards in good condition so any help from members living close to them would be welcomed. (A couple of the originals have recently been cleaned without our having to ask – Ed).



The funding of the boards has been secured through a grant from the National Lottery 'Awards for All' fund. which also paid for the leaflets printed recently. We were granted just over £4,000 in total, and have been able to raise a further donation of £1,000 from the local Notts. and Derbys. branch of the IWA to match

the grant. As we had planned to use Society funds to do this we will be able to contribute this amount to the Trust's survey shortfall above.

The IWA donation was made in a joint meeting walking the canal from Spondon to Draycott, when we had the opportunity to inspect one of the Boards. We had a most enjoyable evening finishing with a warm welcome and sandwiches at the Chequers in Breaston. Our members have been invited to join future IWA Packet Spring, 2011

events e.g at the Rushcliffe Centre, West Bridgeford on 16th September, where you'll be able to hear me tell the members about our progress and plans for the Derby and Sandiacre. Other meetings can be found in the Aegre magazine available on the web.

The Towpath Hedge Restoration.

Over the years since the closure of the canal, its towpath hedge has become overgrown and invaded by tree species other than the original hawthorn.

Restoration work has been done in the past on the Wilmorton and other parts of the southern section of the canal but the members who did that work are no longer available.

Hedge Laying.

Thanks to a grant of £360 from the Spondon Neighbourhood Board and a similar amount of matched funding from the Society, six members of Paul Shepherd's working party have taken a course in hedge laying. This will enable the working party to continue the towpath hedge restoration work on the Spondon to Sandiacre section.

In the practical examination at the end of the course two of our members came second and third out of a class of eighteen, so we should begin to see some smart looking hedges evolving when the working party starts work again in the autumn.

Chain Sawing.

Whilst some of the trees in the hedge are amenable to laying, there are many that have grown too big to be laid and will need more drastic surgery if they are to be retained. To do this will require the use of chain saws.

To enable the working party to carry out such surgery, we have submitted a bid to Erewash Borough Council for funding to send two members on a chain saw training course and to buy protective clothing. This bid is for just over a thousand pounds to which the Society will add half in matched funding.

We will hear in June if we have been successful. Once members have been trained they will be able to work on trees up to 350mm diameter.

PRESS RELEASE (BRITISH WATERWAYS)

WORKS SET TO BEGIN ON RIVER TRENT BRIDGE.

Works at the site of a new bridge over the River Trent are set to begin on Monday.

The works taking place near Shardlow will involve clearing vegetation to establish an access route to the site of the new bridge.

The new bridge will re-establish an important link across the river that has been lost since Long Horse Bridge was closed in 2002 due to fears over its structural safety.

The new bridge has been designed for use by cyclists, horse riders and less able-bodied users and will expand on existing walking and cycling opportunities in the area.

Tony Harvey, Head of Regeneration for British Waterways, said; "There's been a lot of hard work to get to this point but we're now focussed on getting started and re-establishing this important link across the River Trent. The new bridge will tie-in with a number of existing walking routes providing greater opportunities for leisure as well as providing a vital connection over the river that we know the local community has been keen to see re-established.

The initial works will involve clearing scrubland to form the foundations of a walkway to the bridge and are expected to last approximately one week. Works to construct the bridge are expected to commence in the summer with the project set to be completed in the summer of 2012.

The £1.5m bridge project is being managed in a partnership between British Waterways and Derbyshire County Council.

Long Horse Bridge, Shardlow.

Work has begun on the replacement bridge at Shardlow at last, and whilst it is further upstream in order to reduce costs i.e. it's only about half the length of the original, it cannot fulfil the purpose of the old one as it is not possible to bow haul or draw a boat by horse.





Other News.

All Party Parliamentary Waterways Group Governance Inquiry.

The Group met on the 11 May at the House of Commons.

Former Cabinet Member and ex-Waterways Minister The Rt. Hon. Alun Michael MP, chaired the meeting which was form of a formal inquiry into what sort of vehicle should manage the British Waterways network and the appropriate governance for that model.

DEFRA Consultation Document on the Future of Britain's Waterways.

The Inland Waterways Association (IWA) has issued its initial response to Defra's consultation document – A New Era for the Waterways – on the Government's proposals to transform British Waterways into a charity.

Clive Henderson, IWA national chairman, said:

"IWA sees clear advantages for Britain's navigable inland waterways being managed by a third sector body, however, our first reactions to the consultation proposals are that:

- The primacy of navigation on the inland waterways, as a defining influence on how the charity is operated, is too weak thoughout the expressed aims for the organisationand its structure.
- The indicative funding currently does not appear to stack up in delivering a sustainable charity. We appear to be some £15- £45 million p.a. short of what is required.
- The governance proposals need to be fully consistent with localism so that local 'ownership' of waterways can lead to tangible benefits for the waterways, which includes stakeholders being able to say how money can be spent on local priorities.
- The Government must ensure processes are in place to ensure that the Environment Agency navigations can transfer smoothly in 2015/16.
- The classification of the commercial, cruising and remainder waterways must be addressed by Government to meet the charitable purposes of the body in a manner that sustains and enhances existing usage.

We hope our preliminary analysis document will aid others in their efforts to respond properly to the consultation. Our detailed response to the full 29 questions put in the consultation will follow shortly."

Continuous Cruising.

Judgment has been made recently in Bristol County Court (31/3/2011) concerning the interpretation of Section 17 of the British Waterways Act 1995 (relating to Continuous Cruising).

Mr Davies the defendant, kept his boat on the Kennet & Avon Canal in the Bradford upon Avon area and declined to respond to BW's repeated warnings that his boat movement was not sufficient to meet the licensing requirements. These state that to qualify for a BW boat licence, a boat must have a home mooring – somewhere where it may lawfully be kept when not being used for cruising. An exception is made for boats which 'bona fide' navigate throughout the period of the licence. Because Mr Davies did not move sufficiently or agree to comply with its other terms and conditions, BW refused his application to license his boat. Also, because the boat is Mr Davies' home, BW followed its usual procedure of asking the Court to decide on this case.

There was little or no dispute as to the extent of Mr Davies' boat movements. Central to the issue considered by the court was the meaning of the term 'bona fide navigation'.

The Judge noted that Mr Davies' purpose in keeping the boat on the short stretch of canal between Bath and Bradford upon Avon was so that his home was within convenient distance of his place of work and his social circle, and that his purpose in moving the boat was to attempt to escape the requirement to have a permanent mooring. The Judge said: "What is clear to me is that the defendant who is clearly living on the boat cannot successfully claim that he is using it 'bona fide for navigation' by moving it every so often up and down a short stretch of canal."

The Judge's decision is that Mr Davies now has three months (30 June 2011) to remove his boat from British Waterways' canals and rivers.
