3. Adoption of the Minutes of the 2016 AGM

They were agreed as a true record, proposed by Linda Edson, seconded by Elizabeth Newton, carried with one abstention

5. Treasurer's Report

Accounts for the Financial year ending 31 March 2017

Key points; Income:

- Income for 2017 is £5,000 lower than 2016, however 2016 was exceptional and 2017 income levels are broadly similar to 2015; during 2016 we had:
 - Exceptional donation to the Society, we endeavour to direct donations to the Trust which received £2865 in the year allowing gift aid to be claimed;
 - The Trust loan was repaid to the Society;
 - Advertising revenue for the current leaflet (revenue for The Packet received at the start of the current financial year);
 - A successful barn dance.
- Meeting income (entrance fees and raffle) up slightly, but increased profit of £388 (up by £138) as a number of speakers didn't charge a fee.
- Merchandise sales and other show income up by £60.
- Speaker fees, up by nearly £400 Chris Madge had a busy year.
- IWA raffle ticket sales remitted in full to the IWA, the Trust received £277.

Expenditure

- Packet and publishing costs covers 3 editions of the Packet
- Other marketing material covers 10,000 leaflets and 1,000 Draycott Project flyers, cost has been separated for the first time.
- Postage and stationery tripled to £500 for postage of the Packet and membership cards. To reduce this we have successfully converted a large portion of the membership to receiving the Packet by email, postage is now down to less than 100 copies (£60) per edition. Membership cards are also being emailed here possible.
- Work party costs included £150 for a new trailer with the rest being spares, servicing and consumables for various pieces of equipment we use.
- Merchandise purchases reduced over the previous year.
- Training Costs for final assessment Eddy to use a sprayer.

Expenditure for the year exceeded income by £284.

At the year end the Society had a balance in the bank of £5,499.54.

Other Financial Matters

- Membership fees; the Committee believes that the membership fees are set at an appropriate level and should continue at these levels with one alteration: new members should not be offered a reduced concession membership (the concession membership to remain available at £8 (£12 joint) for all members that joined prior to this meeting).
- An additional category of membership has been introduced called "Friends of the Derby Canal" at a minimum rate of £2 per month per person which is equivalent to £24 per year.
- Meeting attendance fees; the committee is proposing no change to the current structure.

I would welcome the Chairman calling for a vote to accept the Society accounts for the year ended 31st March 2017 and the above matters.

Chris briefly reported on the year's Society Activity


- Attended 6 local events

8. Membership report

It has been a successful year with membership now standing at 727 plus 7 groups. We have taken a total of 61 new members since January 1st of which 37% have joined via the website and 10% were Gifts. The new Friend membership has attracted 7 members, 9% of the total.

The membership has lost 26 people of which sadly 3 have passed away.

This year has seen the introduction of electronic membership cards so this has reduced the cost of issuing cards by 60% - the percentage we have on e-mail. This is up by 10%since last year. Further gathering of e-mail addresses would help reduce costs further.

It is worth mentioning that those on e-mail also receive a monthly update via the e-mail as opposed to waiting for the Packet magazine. For anyone not on the list already It is easy to join it by simply sending a short e-mail to membership@derbycanal.org.uk
